

## Later, Late-Term, and No Limit National Abortion Policies

Nations that have authorized abortion generally set pregnancy term limits for abortions based on the gestational age of the baby. A few deliberately set no limits for abortions, and many fail to specify limits for certain reasons even though late term abortions are highly unlikely, such as in almost all of the nations in Africa, Latin America and Oceania. In this working paper, later abortions are second-trimester abortions, beginning at 14 weeks; and late term abortions are 20 weeks gestation or later. The majority of nations, including most nations with second or third trimester limits, may permit later abortions for specified reasons.

Table 1 lists nations that permit abortions during or later than the second trimester of pregnancy. In Australia, policies vary by province or territory. In the United States, policies for second and third trimester abortions vary by state. A total of 52 nations permit second trimester abortions; 8 permit third trimester abortions; and 6 permit abortions with no limits. The 8 include 3 duplicate nations that allow abortion up to the point of viability, which some abortionists construe as second or third trimester.

## Specified Reasons But No Abortion Limits for Some Reasons

In national policies, the specified reasons that abortions are permitted include: physical health (PH) or mental health (MH) of the mother; rape or incest (R/I); fetal impairment or disability (FI); economic or social reasons (ESR); or age limits. In some nations, those who perform abortions only loosely comply with the gestational limits linked to these policies. Further, the policies of most nations authorizing abortion permit some abortions without any specified gestational age limit for one or more specific reasons with approval, which can result in abortions beyond the limits in Table 1. When researching the policies with information available to me, I found a total of 102 nations with one or more of these exceptions that specified no time limit (see Table 2).
