Kamala Devi Harris, Candidate for Vice President of USA

The GLC Series (Country Report) this week focuses on U.S. Senator Kamala Devi Harris (Democrat, California), whom Joe Biden chose as his vice-presidential running candidate for the Democratic Party last week. By her own words, affiliations, actions, use of authority entrusted to her, or voting record, Harris presents herself as a so-called “Christian,” Baptist, a fighter for justice (except for those who are standing justly for the sanctity of human life, or marriage between a man and a woman), a fighter against injustice (except the greatest injustice of abortion), and defender of the “most vulnerable people” (except the truly most vulnerable and defenseless child in the womb). She is a member of a Baptist church, but unlike other Baptist denominations, her particular denomination – American Baptist Churches USA – has a confusing, double-speak resolution on abortion. How can a church denomination or one of its members claim to be “Christian” or the “Church” and support abortion? We will address that hypocrisy next week. Meanwhile, here are Harris’ statements and voting record.

Senator Kamala Devi Harris statements (from her Senate website):

- “Kamala has spent her life fighting injustice.”
- She “resolved to spend her life advocating for those who could not defend themselves.”
- “(A)s California’s Attorney General . . . she worked tirelessly to . . . protect the state’s most vulnerable people.”
- “In the United States Senate . . . she has introduced and cosponsored legislation to . . . make healthcare a right for all Americans . . .” (<https://www.harris.senate.gov/about>).

In response to the U.S. Supreme Court striking down a Louisiana law requiring abortion doctors to have admitting privileges at a hospital within 30 miles of the abortion clinic to protect human life:

“Today’s Supreme Court decision preserved access to abortion. Thanks to this ruling, health clinics in Louisiana will be able to remain open and continue providing safe, legal abortion care. . . . This ruling is especially important for low-income people and people of color . . . impacted by barriers to comprehensive reproductive health care.

“(W)e must . . . keep up the fight to protect access to abortion. That is why it is incumbent upon Congress to pass the Women’s Health Protection Act, which would prohibit states from enacting laws that impose burdensome requirements on access to abortion” (<https://www.harris.senate.gov/news/press-releases/harris-statement-on-supreme-court-striking-down-unconstitutional-restriction-on-abortion>).

California Attorney General Kamala Devi Harris: As Attorney General (2010-2016),

- When a majority of California citizens statewide voted to preserve marriage as an exclusive union “between a man and a woman” (Prop 8), Harris refused to defend the law (and God’s design for marriage). Instead she supported homosexual unions, and filed an *amicus curiae* brief with the court against California citizens trying to defend marriage and the law.

- In 2016, when David Daleiden exposed Planned Parenthood’s scheme of harvesting and selling aborted baby body parts, instead of pursuing the criminals, AG Harris used her office to attack him and violate his constitutional rights. “The pro-abortion California attorney general’s office raided . . . the home of the undercover investigator who exposed Planned Parenthood’s trafficking of aborted babies’ body parts” (<https://www.lifenews.com/2016/04/06/pro-abortion-ag-raids-david-daleidens-home-ignores-planned-parenthood-selling-baby-parts/>).

Senator Kamala Devi Harris voting record: Senator Harris cast votes in the U.S. Senate representing the people of the State of California, as follows between 2017 and 2020:

- Keep Obamacare and its contraception and abortion mandates, and abortion funding;
- Keep the Obama HHS Title X Rule that allowed states to give funds to Planned Parenthood;
- Keep taxpayer funding of abortion (voted against “No Taxpayer Funding for Abortion Act”);
- Against “Born-Alive Abortion Survivors Protection Act” (twice votes against);
- Against “Pain-Capable Unborn Child Protection Act”;
- Opposed defunding “entities that perform abortions such as Planned Parenthood”;
- Opposed parental expanded use of Education Savings Accounts for K-12 and homeschooling;
- Opposed Mike Pompeo for Secretary of State, Senator Jeff Sessions for Attorney General, etc.;
- Supported filibusters on Supreme Court nominations to prevent a vote on the nominees;
- Opposed nominations of Neil Gorsuch and Brett Kavanaugh to be U.S. Supreme Court justices;
- Supported healthcare individual mandate.

Senator Harris’ voting record is available on her own website (yet the titles of the bills on abortion are missing), but Family Research Council *Action* and the National Right to Life Committee assembled voting scorecards (with titles, and some with descriptions and bill numbers), all at these links:

Conclusion: Kamala Devi Harris has been a consistent and forceful advocate for and defender of aborting babies who are alive in their mother’s wombs. By her own life, she cherishes children (her stepchildren); but by her policies, practices and tactics she advocates for the murder of innocent unborn children. By her words she declares she is a fighter against injustice, and yet she fights most strongly for abortion – the greatest injustice of our time and of all human history. By her own life she supports marriage as designed by the Creator between one man and one woman, but by her policies she opposes and destroys the same. By her words and life she thinks that what she is doing is right, but she is deceived, for she advocates for what God Himself called unrighteousness and injustice. She is a wolf in sheep’s clothing (Ezekiel 22:27; Matthew 7:15).

This week I discovered an amazing truth about compassion and women. In Hebrew, the word for “compassion” means “womb” or “a girl, a woman,” or “very tender affection.” The verse I read was: “The LORD’s lovingkindnesses indeed never cease, for His compassions never fail” (Lamentations 3:22; www.blueletterBible.org). The compassion of Father God comes from deep within Himself toward us, and this is exemplified by the life of a baby in a mother’s womb, and the “very tender affection” a mother has for her children. When a girl or woman aborts her own baby, she destroys her identity as a woman, as a giver of life and compassion, and something dies within her soul.

What would Jesus say of Kamala Devi Harris if she stood before His judgment seat today. I think He would say, “I never knew you, depart from Me, you who practice lawlessness” (Matthew 7:23). But while she still lives, to her last breath, Jesus beckons her, “Come to Me, and I will have compassion on you. If you humble yourself and repent, I will save and restore you, and heal your womanly soul.”
