Amy Coney Barrett Nominated to U.S. Supreme Court

The *GLC Series* (Country Report) this week focuses on the nomination of Judge Barrett to be an Associate Justice on the Supreme Court of the United States. Amy (Vivian) Coney Barrett is the daughter of Michael and Linda Coney, wife of Jesse Barrett, and mother of seven children: Emma, Tess, Vivian, John Peter, Liam, Juliet, and Benjamin. Their family lives in South Bend, Indiana – home state of Vice President Mike Pence. She is a federal judge, has taught at Notre Dame Law School since 2002, and is a member of University Faculty for Life – promoting the sanctity of human life. President Donald J. Trump nominated her on Saturday, 26 September 2020, and sent her nomination to the U.S. Senate on Tuesday, 29 September 2020.

Senate Judiciary Committee: On 29 September 2020, Judge Barrett submitted to the Senate Judiciary Committee the questionnaire she was required to complete, accompanied by “over 1,800 pages of documentation, including over 150 speeches and writings, for both academic and popular audiences, and identifying nearly 100 opinions she has written and over 800 appeals in which she has participated” (<https://www.judiciary.senate.gov/press/rep/releases/judge-barrett-returns-senate-judiciary-questionnaire>). Chairman Linsey Graham (R-South Carolina) met with Judge Barrett on 30 September 2020, and made the following statement: “I think [Judge Barrett] is one of the most qualified people to ever be nominated to the Supreme Court” (<https://www.judiciary.senate.gov/press/rep/releases/chairman-graham-meets-with-judge-barrett-america-is-lucky-to-have-you-nominated>).

“According to the standing rules of the U.S. Senate, committees may convene regardless of whether or not the Senate is in session. The Senate Judiciary Committee will proceed with the consideration of the nomination of Judge Amy Coney Barrett to be an Associate Justice on the Supreme Court of the United States on October 12, 2020” (<https://www.judiciary.senate.gov/press/rep/releases/no-change-to-senate-judiciary-committee-supreme-court-nomination-hearing>).

Senate Judiciary Committee hearings schedule (3-4 days):

Monday, 12 October 2020: opening statements of committee members and the nominee;
Tuesday-Wednesday or Thursday, 13-14 or 15 October 2020: questioning of Judge Barrett;
testimony of people who know her well, and of legal experts.

Votes: After the hearings are completed, there will be vote by the Senate Judiciary Committee members. If a majority vote in favor of Barrett’s confirmation, then her nomination will be sent to the full Senate for a final vote on her confirmation as an Associate Justice of the U.S. Supreme Court.
